Y788, who has identified himself as a Peace Officer of the City of Dallas, Texas, and he has duly warned me that I have the following rights: that I have the right to remain silent and not make any statement at all; that any statement I make may be used against me at my trial; that any statement I make may be used as evidence against me in court; that I have the right to have a lawyer present to advise me prior to and during any questioning; that if I am unable to employ a lawyer, I have the right to have a lawyer appointed to advise me prior to and during any questioning and that I have the right to terminate the interview at any time.

Prior to and during the making of the statement, I have and do hereby knowingly, intelligently, and voluntarily waive the above explained rights and I do make the following voluntary statement to the aforementioned person of my own free will and without any promises or offers of leniency or favors, and without compulsion or persuasion by any person or persons whomsoever: I GOT MARRIED MAY 27, 1990. ABOUT A YEAR LATER I WAS LIVING IN THE ASPEN CHASE APARTMENTS OFF FERGUSON ROAD IN A SECOND FLOOR APARTMENT WITH MY WIFE, ANGELA CHAMBERLAIN AND MY TWO CHOW DOGS. ONE WAS BLOND AND ONE WAS BLACK. I CAME HOME EARLY FROM THE STORE WHERE I WAS TRAINING FOR A DISTRICT MANAGER. TO CELEBRATE A RECENT PROMOTION I STARTED DRINKING. I GUESS IT WAS ABOUT 4:00P. I WAS DRINKING STRAIGHT TEQUILA RIGHT OUT OF THE BOTTLE. ABOUT AN HOUR AND A HALF A BOTTLE LATER I REALIZED I NEEDED TO COOK SOMETHING AND I NEEDED TO WALK THE DOGS.
